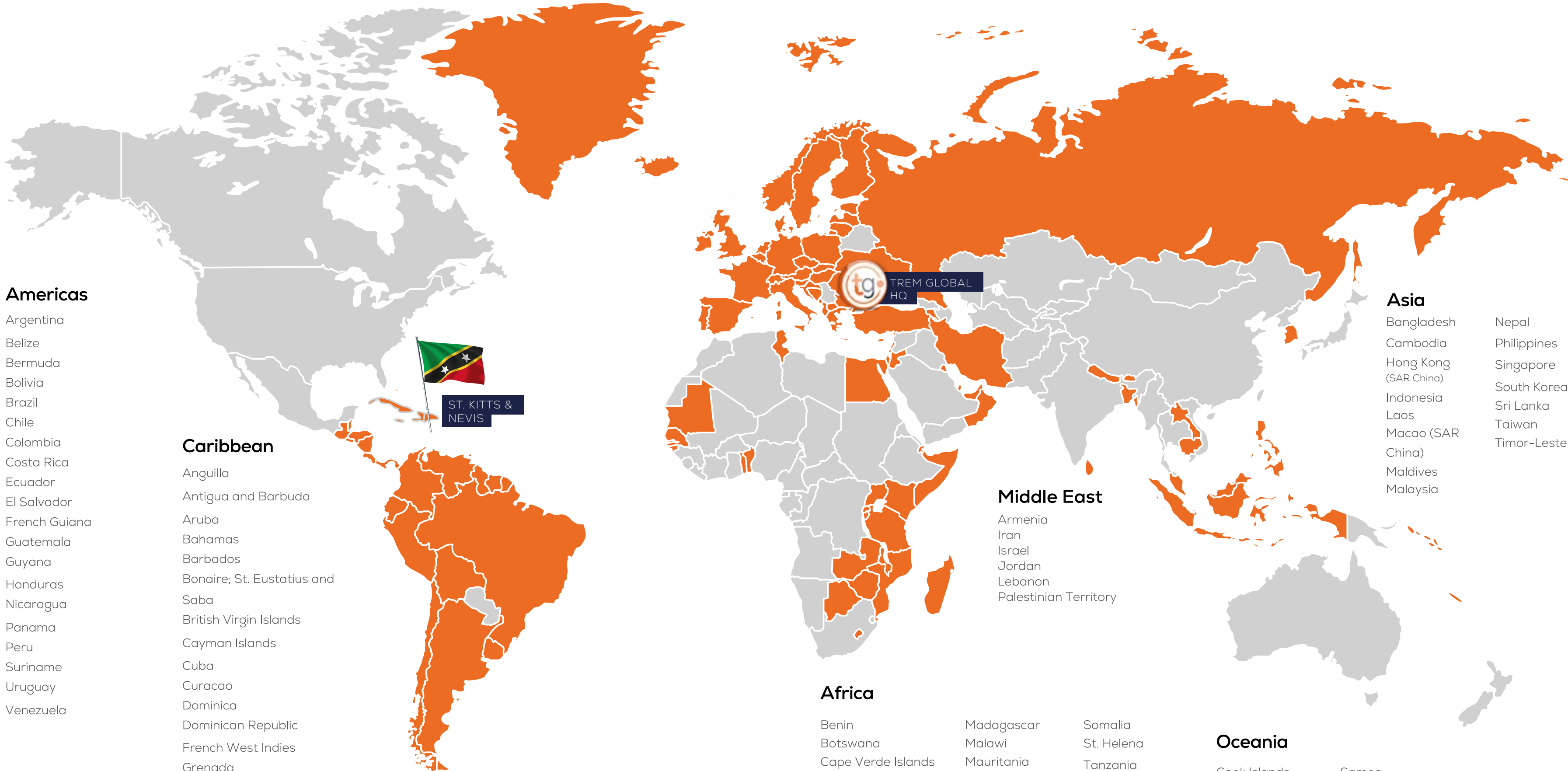
Documents Required for the St. Kitts and Nevis Citizenship Process

- Application Form
- Photo and ID
- Health Certificate
- Passport Application Form
- Sustainable Growth Fund Investment Approval Certificate
- Reference Letter from A Public Figure
- Prohibited Countries Declaration

Note 1: All forms must be filled by the investor. All remaining processes will be carried out by our experienced lawyers.

Note 2: If there is a previous visa refusal from one of the 157 countries that can be travelled without a visa, a citizenship application cannot be made without re-applying to that country and getting visa approval.
